The Miami Bayside Foundation is a non-profit organization that supports minority businesses and education with the goal of advancing economic development in the City of Miami. The Foundation was established in 1986 from a partnership between the City of Miami and Bayside Marketplace developer Jim Rouse. The Miami Bayside Foundation supports minority businesses and education by providing access to funds through a loan program, counseling and training programs, educational scholarships for minorities, and by providing technical assistance to local organizations that are involved in economic development. In 2011, the Foundation financed six loans that created 31 jobs in the City of Miami.

The Miami Bayside Foundation also supports education through a vocational and educational scholarship endowment fund for minority students. Since the endowment fund was created, more than 200 scholarships have been awarded. The Foundation has an endowment of nearly \$1 million at Miami Dade College and additional endowment funds at Florida International University and Florida Memorial University. The scholarship endowment and scholarship fund at Florida International University is bestowed upon first-generation City of Miami students studying business and entrepreneurship. In 2011, 55 City of Miami students studying entrepreneurship at Miami Dade College received scholarships. The Foundation also aids students through a multi-year gift to Breakthrough Miami, an academic enrichment program that supports middle school students from underserved communities.

Miami-Dade County Public Schools commends the Miami Bayside Foundation for its philanthropic endeavors that support education and the economic viability of our community.
