The Resident Council board serves as the liaison between PHCD and residents. Liberty Square Housing has a rich history that dates back to 1937. Liberty Square was built as part of the New Deal and was the first housing project for Blacks in the South.

The Liberty Square Resident Council helps to advocate for safe and secure living conditions for its residents. It provides tenants with self-help initiatives that encourage positive living environments for families living in public housing. The Council works in partnership with the Miami-Dade Public Housing Authority, U.S. Housing and Urban Development, Miami-Dade County Commissioner for District 3 and the City of Miami Commissioner for District 5.

The Council has been fighting for the installation of working cameras and speed limit signs to ensure safety, improved lighting, broadband and wireless service to provide improved education and job training programs, community center access, increased police and private security presence, as well as the securing of the entrance and exit of the housing development.
