Since its inception, Miami-Dade County Public Schools (M-DCPS) and Miami-Dade College (MDC) have jointly purchased appropriate insurance coverages to adequately protect the New World School of the Arts (NWSA). MDC secures proposals for the coverage through their contracted brokers and provides the information for review by the Office of Risk and Benefits Management to ensure the coverage is appropriate and at a competitive cost for the South Florida marketplace.

Annually, the Board has authorized payment for one-half of the annual premium for such coverages pursuant to the authority provided by State Board Rule 6A-1.012(15), wherein the Board is authorized to directly negotiate and enter into contracts for insurance, risk management programs, or third party administrators, making such acquisitions through the bid process or by direct negotiation and contract.

MDC has now provided staff with the renewal terms of the commercial package policy which is effective August 13, 2014 to August 12, 2015.

The total renewal premium resulted in increase of \$1,948.85 or approximately 6%, with the Board's share consisting of \$974.43. With a tightening in the insurance marketplace, this increase is well within normal ranges. All terms and conditions of the renewal policy remain the same as expiring. The policy provisions are as follows:

Staff is requesting authority to reimburse MDC for one-half of the commercial package policy and excess insurance policy premium in the amount of \$17,245.75 representing one half of the annual renewal premium for the commercial package and excess insurance policies for the New World School of Arts, to Miami-Dade College, covering both Miami-Dade County Public Schools and Miami-Dade College, with Philadelphia Insurance Company (A.M. Best A+, IX), through Arthur J. Gallagher Risk Management Services, Inc., effective August 13, 2014 to August 12, 2015.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida authorize reimbursement of \$17,245.75, representing one half of the annual renewal premium for the commercial package and excess insurance policies for the New World School of Arts, to Miami-Dade College, covering both Miami-Dade County Public Schools and Miami-Dade College, with Philadelphia Insurance Company (A.M. Best A+, IX), through Arthur J. Gallagher Risk Management Services, Inc., effective August 13, 2014 to August 12, 2015.
