It was created by three concerned women who wanted to make a difference in the lives of children and families who were facing negative life circumstances. In its early days of service, CAW focused on increasing self awareness and basic life skills like reading. The organization currently employs 29 professionals, including certified teachers, licensed social workers and other staff. It operates from nine locations and served more than 1,000 people last year alone.

CAW has crafted one of the nation's leading comprehensive approaches to offering services that infuse cultural awareness into programs that help children and parents by ending the generational pattern of poverty. It provides several programs such as *Cultural Impact*, which educates them about their rich artistic and academic legacy and the culture of success. Roughly 90 percent of its clients are of African descent. *Olde Fashioned Manners* emphasizes and normalizes self-respect, courtesy and positive communications. CAW was recognized by Miami-Dade County Public Schools with a 2013 Beyond the Bell Award and the Outstanding Dade Partner Award from COPE Center North.

Concerned African Women is to be commended for its tireless work on behalf of the children and families of Miami-Dade County. This important work has enriched the lives of generations to come.
