The 1983 McMillan Mathematics Teacher of the Year went on to chair the Math Department at Hammocks Junior High School and was selected as the 1984 Mathematics District Teacher of the Year. She went on to hold numerous leadership titles within the county, including regional curriculum coordinator, school-site administrator, and regional administrator.

In 2009, Millie assumed the role of Associate Superintendent/Chief Academic Officer for M-DCPS. Ms. Fornell's many achievements in this role include the increase of participation and performance of students in Advanced Placement and Dual Enrollment courses. Ms. Fornell retired in June 2014 as the Chief of Staff for M-DCPS Superintendent Alberto M. Carvalho. During her time in this position she oversaw the successful implementation of the District's Digital Convergence Project.

Millie's commitment to the District's strong focus on the effective use of data-driven instruction and the reframing of the District's priorities to reflect the singular goal of student academic achievement has heralded unprecedented student achievement and increases in graduation rates for our most fragile communities.
