Leadership Miami is a program sponsored by the Miami Area Chamber of Commerce. The program is designed to stimulate and develop community leaders while creating a sense of community stewardship in the participants and all citizens of the Miami-Dade. The program not only provides training, but also recognition and networking to leaders. Training consists of 10 sessions held monthly for nine months that include: orientation and team building, economic development, government day and legislative goodwill tour, education, environment, Native American and agribusiness, non-profit/healthcare, history and future of Miami and graduation. Participant selection is based on a set of criteria to ensure that each team consists of diverse backgrounds and experiences.

A primary component of the program is a community service project. Each team must complete a project that benefits the community and has long-lasting impact. A very significant project of the 2014-2015 class is Accelerate Literacy — which was formed to provide underserved children and their families with resources to promote a love of reading. Studies show that access to books is the number one way to improve reading achievement for low-income children.

Accelerate Literacy has launched a community-wide initiative to collect 10,000 new and gently used books for children up to 8 years old by March 31, 2015. To accomplish its goal, the team is also bringing together community leaders and advocates in a literacy symposium in March focused on collaboration and collective problem solving. On Saturday, April 18, 2015, the class will host a family-friendly event to celebrate reading with kids, their families, and friends.
