APPLICATIONS

Section 1002.33, F.S., authorizes the establishment of charter schools in Florida. As provided in Section 1002.33(6), F.S., and School Board Policy 9800, Charter Schools, Miami-Dade County Public Schools (M-DCPS) receives and reviews charter school applications from individuals and/or organizations. Thirty-six (36) applications were received for the 2014 cycle to operate a charter school in Miami-Dade County. Pursuant to Section 1002.33(6)(b)(3), F.S., a sponsor must approve or deny an application no later than 60 calendar days after the application is received unless the applicants have agreed in writing to extend the statutory timeline.

EVALUATION

Pursuant to School Board Policy 9800, *Charter Schools*, (School Board Policy) the District reviews all applications using an evaluation instrument developed by the Florida Department of Education (FLDOE) and may include additional information or documents requested by the District. The Standard Model Application includes standards of evaluation, certification and assurance declarations. The Sponsor shall deny any application that does not comply with the statutory requirements and/or Sponsor's instructions for charter school applications.

The Superintendent has appointed the Application Review Committee (ARC) with the responsibility to review and evaluate charter school applications after an initial technical review conducted by staff. The ARC is comprised of representatives from various District departments and is charged with identifying deficiencies in the written application and/or areas that require clarification to fully evaluate the quality of the application or the capacity of the applicant to properly implement the proposed plan.

Pursuant to School Board Policy, two (2) charter school applications are being presented for final consideration by the School Board. Detailed in the chart below is a summary of the charter school applications. Additional details can be found in Attachment A and in the evaluation forms which are included and incorporated by reference in this Board item.

NEW CHARTER CONTRACTS AND AMENDED CHARTER SCHOOL CONTRACT

Section 1002.33(7), F. S., states that the major issues involved in the operation of charter schools be considered in advance and written into a charter school contract between the charter school and the School Board following a public meeting. Pursuant to School Board Policy 9800, Charter Schools, the M-DCPS' Charter School Contract Review Committee (CRC) negotiated two (2) new charter school contracts and one (1) contract amendment. The recommendations are as follows:

Any significant increase in charter school student enrollment (Charter FTE) directly impacts the District's operating budget as well as instructional and non-instructional staffing levels. The three (3) charter school contracts in this Board item represent an increase in overall charter school enrollment. To ensure that the District's financial position remains positive, Board authorization is requested to allow a Reduction-in-Force/Layoff only if it becomes necessary. Any such Reduction-in-Force/Layoff affecting instructional and non-instructional staff would be implemented in accordance with School Board policies and applicable collective bargaining agreements. The number of position reductions will not exceed the stated Initial Loss included in this item and will be re-evaluated and adjusted in subsequent years to reflect changes in FTE. The impact caused by each contract is provided in Attachment A.

 - i. Sports Leadership and Management (SLAM) High School North Campus;
 - ii. Sports Leadership and Management (SLAM) Middle School North Campus.
- 2. Approve two (2) new charter contracts, under Section 1002.331, F.S., **High-Performing Charter Schools**, with:
 - a. Mater Academy, Inc., on behalf of:
 - Mater Academy West, for a term of five years, commencing with the 2016-2017 school year and ending on June 30, 2021; and
 - Mater International Academy, for a term of five years, commencing with the 2015-2016 school year and ending on June 30, 2020.
- 3. Approve one (1) amended charter school contract with BridgePrep Academy, Inc., on behalf of BridgePrep Academy of Village Green, to (i.) add a permanent facility located at 13300 S.W. 120th Street, Miami, Florida 33186; Folio No. 30-5914-000-0040; (ii.) increase enrollment from 550 students to a maximum of 600 students, commencing with the 2015-2016 school year, and ending on June 30, 2016.
- 4. Approve a Reduction-in-Force/Layoff as needed, only to the extent described in this item as Total Initial Loss, in accordance with School Board policies and applicable collective bargaining agreements.

Initial Year Loss for the 2015-2016 SY: The revenue and positions indicated as "Initial Year Loss" provide an estimate of the potential impact on the District's General Fund (\$903,685) instructional staffing (11 positions), and non-instructional staffing (7 positions). The loss of revenue is based on 95% of FEFP funds per student and 75% of the initial year enrollment projection that the District will not realize for the current fiscal year.

Initial Year Loss for the 2016-2017 SY: The revenue and positions indicated as "Initial Year Loss" provide an estimate of the potential impact on the District's General Fund (\$2,078,042) instructional staffing (22 positions), and non-instructional staffing (14 positions). The loss of revenue is based on 95% of FEFP funds per student and 75% of the initial year enrollment projection that the District will not realize for the current fiscal year.
