The June 30, 2014, financial statements of the seven above schools reflect adequate or ample year-end financial positions. However, regarding the Doral Academy schools above (including Just Arts and Management), we continue to have concerns about the composition of Doral Academy, Inc.'s governing Board and with Doral Academy Charter High School's payments to Doral College, Inc. Regarding Somerset Academy Charter High School, during the September 23, 2013, meeting of the Governing Board of Somerset Academy, Inc. the Board approved an educational services agreement between the High School and Doral College, Inc. in the amount of \$100,000 for the 2013-2014 fiscal year. The agreement approved and executed does not contractually guarantee that the High School will receive any benefit from the College in exchange for its payment of public funds.

Two Community Based Organizations (CBOs) Which Are Free Of Significant Fiscal Concerns

Additionally, we reviewed the June 30, 2014, audited financial statements of the following two CBOs for which the District contracts to provide alternative education services. We found both CBOs to be financially sound.

✦ These schools are currently in the process of re-negotiating their contracts with their management company to reduce the term and more fully comply with best practices.

* These schools appear to have made interest free advances or transfers to other charter schools governed by the same legal entity when no goods, services or deliverables were provided in exchange by the receiving school. We have requested guidance and clarification from the Florida Department of Education as to the propriety and legality of this practice.

¹ School closed at end of 2013-14 School Year due to poor academic performance.
