**SUBJECT: AWARD BID NO. – ITB-14-009-DD TRANSPORTATION FOR
SPECIAL NEEDS STUDENTS**

Procurement Management Services in collaboration with the Department of Transportation, released the above-referenced solicitation. The purpose of this Invitation To Bid is to purchase, at a firm unit price, quantities, as may be required, of transportation services for special needs students, the homeless and students in foster care, for The School Board of Miami-Dade County, Florida. Student participation may vary based upon the requirements and the needs of the student. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but the District is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' website, the Demandstar website, The Miami Times and the Diario Las Americas newspapers, as well as emailed to 33 potential bidders.

The initial term of this bid shall be for one (1) year, commencing July, 1, 2015 through June 30, 2016, and may by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidder, be extended for three (3) additional one (1) year periods.

Upon receipt of the bids and further negotiations with American Logistics Company, LLC, Procurement Management Services was able to reduce pricing by approximately 46%. The table below illustrates the savings as follows:
