SUBJECT: AWARD BID NO. ITB-14-036-AC – FRESH PRODUCE

Procurement Management Services, in collaboration with the Department of Food and Nutrition, released the above-referenced solicitation. The purpose of this bid is to purchase, at a firm unit price, fresh, high-quality, seasonal and local produce, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. In addition, this Invitation To Bid was advertised on the Procurement Management Services website, the Demandstar website, as well as emailed to 55 potential bidders.

The initial term of the bid shall be for one (1) year commencing July 1, 2015, through June 30, 2016, and may by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidder, be extended for four (4) additional one (1) year periods.

A price comparison was conducted against the District's current contract and reflected a cost savings of approximately \$16,847. Upon benchmarking against other school districts, and further negotiations with the Mac Edwards Produce Co., Inc. and The Produce Connection, Inc., Procurement Management Services was able to obtain an additional \$19,770. This resulted in a total cost savings of \$36,617 annually.

The contract shall be awarded to a primary and alternate vendor, as this is in the best interest of the District. Based on the criteria listed in the solicitation, two (2) vendors are being recommended for award. The awarded vendors are currently registered to do business with the District.
