On March 23, 2015, competitive bid solicitations were issued seeking qualified firms to perform roofing services. For the Open Market we had nine firms pick up the project manual and four submitted bids. For the M/SBE contract we had twelve firms pick up the project manual and two submitted bids. Two separate term contracts were advertised to encourage participation by smaller firms and provide flexibility to the Board, in particular, during emergencies.

The bid solicitation included a term bid task catalog which included a list of materials and services required by the District and their associated estimated costs. The unit prices in the line items in the task catalog include all materials, labor, supervision, equipment, overhead and profit and any other charges required for the work. Contract award is recommended on the basis of a competitively bid adjustment factor to be assigned to the unit price in the construction task catalog.

Each term contract is for roof related work including emergency roof repair and clean-up crew for water, fire or other damage. Individual projects shall be initiated through a work order under the corresponding Roofing Term Contract. The compensation amount and duration of each project will be specified with each work order assignment.

For the Open Market the initial maximum amount not to exceed \$2,000,000.00, which may be extended up to two (2) times within the same term year, up to a total maximum annual amount of \$6,000,000.00. For the M/SBE the maximum contract amount shall be \$200,000.00, except that if the maximum is reached prior to the expiration of the contract period, the contract may be extended one (1) time for equal amount, at the direction of the Superintendent or his designee, provided that the payment and performance bond is extended accordingly.

For the Open Market the term of the contract will be twelve months renewable for two (2) additional terms of one year, on an annual basis, at the discretion of the Board. For the M/SBE the term of the contract will be twelve months and may include two (2) renewal options for one (1) additional year with its associated extension.

Bids were received on April 21, 2015 by The School Board of Miami-Dade County, Florida for both term contracts. The lowest responsive bidders are:
