Neurodiversity is a concept promoted by an international movement that recognizes and respects neurological differences. Advocates of neurodiversity encourage viewing autism and other neurological differences as variations in the brain wiring of individuals who can bring exceptional value to the world. As celebrated professor and autism activist Temple Grandin so aptly puts it, "The world needs different kinds of minds." This idea has inspired Miami Palmetto Senior High School student Connor Cunningham to share his personal experiences and help others develop tolerance.

Through his organization, Stand in My Shoes™, Connor has launched a Miami-based educational campaign that provides a platform for children and adolescents to explore the wide-ranging experiences and science of autism and neurodiversity. Connor, 16, has Asperger's syndrome, a form of high-functioning autism. Throughout the last school year, Connor has spoken to more than 500 children and teachers at Sunny Isles Beach K-8 presenting to groups of elementary and middle school students. Connor shared facts, personal stories, humor and games to help students understand what life on the Autism Spectrum Disorder (ASD) is like and create awareness and tolerance.

For his efforts and advocacy, Connor has been named Outstanding Student Volunteer by the University of Miami Center for Autism and Related Disabilities and was asked to speak at the UM-CARD gala. The purpose of this board item is to recognize Connor Cunningham for inspiring young people to develop tolerance and understanding of those living with ASD.
