Ms. McLeod Bethune was the child of slave parents, revered educator and a government consultant. The NCNW is known as the “organization of organizations” and supports all women’s activities through bringing women of all races and cultures together.

A voluntary non-profit membership organization, the NCNW’s mission is to increase opportunities for and enrich the lives of African-American women as well as their families and communities. The organization supports research, advocacy, national- and community-based programs in this country and Africa. It has 39 national affiliates and more than 200 community-based sections. The NCNW supports almost 4 million women.

The NCNW Metropolitan Dade County Section was created on January 21, 1990 under its’ first president, Reverend Ann McRae. The organization is currently led by its president Sister Sandra K. Gipson. The Section supports community events such as its Affordable Healthcare Summits, American Diabetes Association 5K Walk, Women’s History Month Breakfast, College Tours, End Domestic Violence Walk and Youth Mentoring Program. In addition the NCNW is the recipient of the National Headquarters recognition for its HIV/AIDS Testing and Awareness Day, a City of Miami proclamation and the City of Miami Commendation.
