Today, students spend an average of 7.5 hours a day using entertainment media such as video games, which leaves little time for physical activities. Only one-third of children are getting the recommended 60-minutes of physical activity per day, an essential component of a healthy lifestyle.

Fit Kids Day involves students, parents, schools, elected officials and community organizations to bring awareness to the current epidemic of childhood obesity. The concept is simple: create a day for kids to play outdoors. All of the Fit Kids Day events are free and include a variety of nutritious food and cooking demonstrations, as well as various physical activities and sports, such as volleyball, soccer, lacrosse, tennis, martial arts, yoga and dance.

Fit Kids Day ambassadors are school-age children who volunteer their time to help plan and coordinate the events, plan activities and decide on the food and music. They contact businesses to ask for sponsorships and reach out to schools and local governments to find host sites for the events.

Sofia, now a sophomore at Carrollton School of the Sacred Heart, has expanded the program to Key Biscayne, Miami, and North Miami. The program also gives kids the opportunity to be leaders in their communities.
