They meet with local church pastors, commissioners and representatives with the primary focus of expanding their relationship and advocating for students educational needs. The FCM PTSA provides innovative fundraising opportunities like the Harlem Wizards visit, where administrators, teachers and staff play a "Globetrotter-like" team and promote fitness while having fun. They also participate in school book fairs, fund raisers, pizza sales, carnival planning, and decorating the school to promote any and all activities that provide a sense of community and unity so that Vineland K-8 Students feel they are in their "second home". The financial support they provide is focused on the students of Vineland K-8. With that focus, and in coordination with the teachers and administration, they were able to help implement robotics as an elective in the Upper Academy. The PTSA has also purchased two mobile computer labs, reading programs, countless books, incentive material for the children and technology upgrades.
