The Educational Facilities Impact Fee Fund, Special Purpose Financial Statements were audited by C Borders-Byrd, CPA, LLC. The auditors concluded that the special purpose financial statements present fairly in all material respects the financial position of the Educational Facilities Impact Fee Fund, which also constitutes an unmodified opinion. No findings were reported.

Total revenues for the Educational Facilities Impact Fee Fund, Special Purpose financial Statements for fiscal year 2015 were \$34,941,307, a substantial increase from fiscal year 2014. The ending fund balance for the year ended June 30, 2015 was \$16,628.411, a considerable increase from the prior fiscal year.

The School Board Audit and Budget Advisory Committee reviewed this report at its December 1, 2015, meeting and recommended transmitting it to the School Board.
