On December 10, 2014, the Board commissioned R.J. Heisenbottle Architects, P.A., as the Architect/Engineer (A/E) of Record, Sheltered Market for Small Business Enterprises, for General Obligation Bond (GOB) funded Project No. 01433400, and Non-GOB Project No. 01436100 at Design and Architecture Senior High School (DASH). On April 10, 2015, staff requested that the A/E stop services for the projects, until the Scope Validation Report was approved by staff.

At its December 2, 2015 meeting, the Board authorized the Superintendent to issue an Invitation to Bid for the possible sale of a portion of the DASH property. As a result, the projects originally envisioned for DASH need to be cancelled and the A/E of Record terminated for convenience by the Board.

R.J. Heisenbottle Architects, P.A., was notified on January 22, 2016, of the Board's intent to terminate the Agreement, without cause, per Article XIII of the Agreement. The A/E performed in accordance with the terms and conditions of their Agreement. completed the Scope Validation Report and was compensated per the payment schedule for the projects. No further services were provided, and therefore, no further compensation or termination costs are due to the firm.
