The Children's Movement of Florida is a citizen-led, non-partisan movement created to educate political, business and civic leaders, as well as parents across the state, about the crucial importance of making the well-being and education of young children, Florida's highest priority. The movement does not advocate for new taxes or increasing existing taxes. Rather, it is built around the belief that Florida's children must be viewed as the highest priority when it comes to receiving a full and fair share of the state's resources.

The Movement works to improve Florida's voluntary pre-K program, implement high-quality parent skill-building programs, secure health insurance for all children, ensure screening and treatment for children with special needs, and provide high-quality mentoring programs. Over its six year history, it has advocated for important legislation in support of initiatives benefitting early childhood programs.

The organization was founded in 2010 by David Lawrence Jr., a nationally renowned journalist and former publisher of The Miami Herald. After retiring from The Herald in 1999, Lawrence devoted himself to children's issues, leading The Early Childhood Initiative Foundation, serving on the Governor's Children and Youth Cabinet from 2007-2016, and emerging as a national leader in the field of early childhood. He was a key figure in the passage of the constitutional amendment making available Pre-K to all of Florida's four year olds. Twice, he led the successful passage of The Children's Trust, a vital source of funding for the needs of Miami-Dade's children.

This month, as we celebrate the Week of the Young Child, it is only fitting that we recognize an organization and an individual who have done so much to advance the education and well-being of our youngest children.
