His professional longevity shows adaption to changing markets, with the ability to make tough decisions in budgets, operations and personnel matters, while maintaining a team oriented and collaborative spirit. "Chip" Richards' life and work experience has brought him numerous awards and recognition including membership in the Nomination Committee for the National Academy of Television Arts and Sciences, select and recommend Executive Counsel for the organization; member of the National Academy of Television Arts and Sciences Scholarship Awards Committee, awarding over \$80,000 in scholarships a year. Ms. Castro also spearheaded the application process for the State's School Infrastructure Thrift Trust, which was established in 1998 as an incentive for Districts to implement frugal construction practices. Through her efforts, the State awarded the District over \$11 million, which was used for the purchase and construction of school facilities. Ms. Castro initiated the application process for the State's Effort Index Grant, which awards funds to Districts that demonstrated local funding effort for school construction. This resulted in a \$62.7 million award, the highest award to any single district. She helped establish and manage the Direct Purchase of Construction Materials, which has saved the District over \$15 million in sales tax and mark-up by contractors. Ms. Castro also introduced a program for the bulk purchase of HVAC equipment in 2013, which saved the District \$2.7M (53%) in equipment cost.
