Jayson Jackson, President of the Youth Council was awarded Gloster B Current Leadership Award for outstanding leadership and community service.

The NAACP ACT-SO was created to provide a vehicle for concerned adults to mobilize a total assault on negative community climate and to provide an alternative to those forces that spawn violence, defeatism, flimsy self-confidence, low self-esteem and, in certain instances, the glorification of ignorance.

Founded by Vernon Jarrett, ACT-SO was introduced in August 1977 at the Lord Baltimore Hotel during the national convention of the National Association of Black Journalists (NABJ), prior to the address of Dr. Benjamin Hooks, incoming NAACP Executive Director. Dr. Hooks was so impressed with the idea that after brief contemplation he announced the NAACP's endorsement during his address before the NABJ. The following year, ACT-SO became a national program of the NAACP with the participation of 19 branches of the organization. Since then, ACT-SO has grown by word of mouth with more than 1,000 cities and small towns participating.

The actual creation of ACT-SO has its origins in a variety of memory sources based on the lives of many successful black leaders, educators, performers, ministers, and other successful professionals. The original goal of ACT-SO was to take inventory of human community resources and then the total mobilization of black adults who have gained a measure of stability from the civil rights victories of yesteryear. ACT-SO recruits adults and students who serve in various capacities, such as coaches, instructors, chaperones, and cheerleaders in the arena of academic promotion.

Every year, the NAACP recognizes outstanding youth through its ACT-SO competition. This year's winners include 2016 National winners in the Gold category Kebra-Seyoun Charles of New World School of the Arts with Instrument Classical and William Gordon of Miami Norland in Poetry Performance.
