Procurement Management Services, at the request of the Instructional Technology Department released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to purchase, at a catalog discount, audio visual, television, photographic, misc. equipment, supplies and installation services, for various departments servicing Miami-Dade County Public School District. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, the Demandstar website, BidNet, Florida Bid, *The Miami Times* and the *Diario Las Americas* newspapers as well as emailed to 20 potential bidders.

The initial term of the bid shall be for a two (2) year period, commencing September 7, 2016 through September 6, 2018, and may, by mutual agreement between the School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods.

In this ITB, The District requested catalog discount on 175 items. Pursuant to Board Policy 6320, Bidding Process – Competitive Bidding Requirements describes the procedure and guidelines to be used for bidding on the required quantities. School sites and/or district offices will contact the awarded vendors, using a Request for Quote.

Strategies were employed to increase SBE/MBE participation; however, the Goal Setting Committee recommended that this solicitation be open, not sheltered, as a large number of SBE/MBE vendors were not identified within the commodity code(s).

Eighteen (18) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to 17 vendors, (16 primary vendors and one vendor only as an alternate, three (3) of which are SBE/MBE certified).
