In 1993 she joined the National Park Service where she distinguished herself by leading restoration efforts at six historic buildings in Bathhouse Row, a National Historic Landmark District at Hot Springs National Park in Arkansas. It boasts the grandest collection of bathhouses of its kind in America. Thanks to her efforts four of these buildings reopened and now house modern spas, serve as dining facilities, and are home to Artist in Residence programs. She is the first woman to serve as Superintendent of Hot Springs National Park since it was legislated by the United States Congress in 1832.
