In 1995, she was named Principal at George Washington Carver Elementary where she implemented one of the first School of Choice models as well as the first Italian Language Program in Miami-Dade County Public Schools. In 1999, she was named the founding Principal at Dr. Carlos J. Finlay Elementary School, a Dual Language program and Florida International University’s College of Education’s first Professional Development school, an accomplishment that she highlights as one of the most special in her career.

Under her most recent appointment as Personnel and Technology Operations Administrative Director at our Central Region Offices, Mrs. Gimenez has served 112 schools, overseeing over 300 administrators and over 86,000 students.

During her distinguished career, Mrs. Gimenez has received numerous awards and recognitions including her installation to the Miami Dade-College Alumni Hall of Fame, the Florida International University Golden Medallion for Outstanding Alumna, as well as the Golden School Award from the Florida Department of Education while serving as Principal in George Washington Carver Elementary and in Dr. Carlos J. Finlay Elementary. She has also received gubernatorial appointments to the state's Educational and Equity Task Force, and the Juvenile Justice and Delinquency Prevention State Advisory Group.
