Procurement Management Services, at the request of the Department of Food and Nutrition, released the above-referenced solicitation. The purpose of this Invitation to Bid is to establish a revenue generating contract, to provide healthy snacks and beverage vending machines for Miami-Dade County Public Schools at school sites and at designated non-school district site locations. This Invitation to Bid was advertised on the Procurement Management Services' website, the Demandstar website, BidNet, Florida Bid, The Miami Times and EL Diario Las Americas newspapers, as well as emailed to 71 potential bidders.

The initial term of the bid shall be for a two (2) year period, commencing March 1, 2017 through February 28, 2019, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods.

Strategies were employed to increase SBE/MBE participation. The Goal Setting Committee recommended that this solicitation be open, not sheltered, as a large number of SBE/MBE vendors were not identified within the commodity code(s).

Two (2) vendors responded to this advertised bid and are both recommended for award.
