SUBJECT: COMMISSIONING OF VEITIA PADRON INCORPORATED, AS CONSTRUCTION MANAGEMENT AT-RISK FIRM (SHELTERED MARKET - SMALL BUSINESS ENTERPRISE) FOR GENERAL OBLIGATION BOND FUNDED RENOVATIONS AND NEW P.E. SHELTER AT EARLINGTON HEIGHTS ELEMENTARY SCHOOL, LOCATED AT 4750 N.W. 22 AVENUE, MIAMI, FLORIDA 33142; PROJECT NUMBER 01423200

Introduction:

In June 2017, a solicitation (Request for Qualifications 153 - Sheltered Market) was published to competitively select Construction Management at-Risk (CMR) firms for the following General Obligation Bond (GOB) Funded Projects under the "Procedures for the Selection of Construction Management (CM), CM at-Risk and Program Management Services" (Pilot Program 2nd Revision September 6, 2016):

- Renovations and New P.E. Shelter at Earlington Heights Elementary School
4750 N.W. 22 Avenue, Miami, Florida, 33142, Project Number 01423200
- Renovations at Lenora Braynon Smith Elementary School
4700 N.W. 12 Avenue, Miami, Florida 33127, Project Number 01529200
- Renovations at North Miami Beach Senior High School
1247 N.E. 167 Street, North Miami Beach, Florida 33162, Project Number 01327000

Eleven (11) firms responded to the solicitation. Three (3) firms were not evaluated due to incomplete submittals. Eight (8) firms were evaluated and all were shortlisted and invited to interview. On August 23, 2017, all firms interviewed and were subsequently ranked by the Selection Committee, as follows:

Note: All prime firms hold a current M-DCPS Minority/Woman Business Enterprise (M/WBE) and a current M-DCPS Small Business Enterprise (SBE)/Micro Business Enterprise (MBE) Certificate.

This solicitation includes mandatory SBE/MBE sub-consultant and sub-contracting goals, and a Local Workforce Utilization Goal for this project (determined by the M-DCPS Goal Setting Committee), as follows:

Selection:

In accordance with the solicitation and interview process, the highest-ranked firm was selected to negotiate for the highest-valued project (Earlington Heights ES), the second-ranked firm for the second-valued project (Lenora Braynon Smith ES) and the third-ranked firm for the third-valued project (North Miami Beach SHS).

Veitia Padron Incorporated (VPI) is the highest-ranked firm and therefore, negotiated for the highest-valued GOB funded Renovations and New P.E. Shelter project at Earlington Heights ES. The second and third-ranked firms successfully negotiated their respective projects and are being presented under separate Board agenda items. Negotiations with VPI were successfully concluded and VPI has agreed to provide the required CMR Pre-construction Services, as follows:

School Profile:

The existing facility, on a 7-acre site, is comprised of 8 permanent buildings and associated covered walkways, built between 1936 and 1967 with a total of 49,792 GSF.

Project Scope:

The preliminary scope of work for this project consists of campus-wide miscellaneous renovations, but is not limited to:

- Demolition of 1 portable and site restoration,
- Provide a new P.E. Shelter

- Re-coating and re-striping of hardcourts, parking lots and drives,
- Replacement/repair of basketball standards,
- Replacement of playground including equipment, impact surface and shade structure,
- Selective roofing,
- PA, security camera and security alarm systems upgrades,
- Replacement of HVAC equipment and controls to DDC (as required),
- Provide HVAC system at kitchen,
- Miscellaneous safety-to-life and electrical upgrades,
- Renovation of group toilet rooms (including ADA upgrades),
- Selective replacement of campus-wide domestic water and sanitary sewer piping (as required),
- Repair/replacement of stage, classrooms and administration areas flooring,
- Selective replacement of doors and windows,
- Selective replacement of interior lighting,
- Repair of exterior coral rock finish,
- Selective replacement of ceramic tile flooring,
- Replacement of electric water heaters,
- Repair of emergency generator, and
- Selective interior/exterior paint.

Scope of Services:

The successful CMR entity will be required to provide Pre-construction Services (during all phases of programming and design). The CMR may be required to provide Guaranteed Maximum Price (GMP) proposal(s) and construction services; or the Board may re-advertise the required services and select another CMR; or select an alternate construction delivery method.

The project must be designed, phased, coordinated and constructed to maximize safety and minimize disruption to the existing, occupied campus.

Construction Delivery Method:

To minimize disruption to students and faculty during construction, and in accordance with the M-DCPS Construction Delivery Method Matrix, the CMR delivery method has been selected for this project. However, the Board reserves the right to utilize an alternative delivery method, if deemed to be in the best interest of the Board.

Office of Economic Opportunity (OEO) Review:

M-DCPS' OEO staff established the SBE/MBE and M/WBE certification status of the prime firm and each sub-consultant and verified the existence of a Memorandum of Understanding, outlining roles and responsibilities, as follows:

Construction Budget: \$2,463,602 (GOB funded)

Project Schedule:

VPI has agreed to the following A/E's document submittal schedule (and the CMR draft document submittal schedule):

- Draft Scope Definition Program and Master Plan December 1, 2017
- 100% Final Scope Definition Program and Master Plan January 8, 2018

Design milestone dates (contingent on Final Scope Definition Program approval by January 26, 2018) are as follows:

- Board Commission of A/E (Part 2 services): March 14, 2018
- Phase I - Schematic Design: April 12, 2018
- Phase - II/III Construction Documents 50% complete: June 11, 2018
- Phase - II/III Construction Documents 100% complete: August 9, 2018

Project construction milestone dates are as follows:

- Board Award - Guaranteed Maximum Price (GMP): January 2019
- Construction - Substantial Completion by: March 2020
- Final Completion by: April 2020

Terms & Conditions:

1. VPI has agreed to a lump sum fee for CMR Pre-construction Services of \$24,750, which represents approximately 1.00% of the construction budget of \$2,463,602. In consideration for entering into this Agreement, the CMR agrees that any and all

costs and fees incurred by the CMR associated with the CMR's performance of all pre-construction services set forth in the Agreement shall be borne solely by the CMR. Pre-construction services fees shall be paid based on completion of the following listed phases/deliverables:

2. The CMR agrees to provide the requisite pre-construction services for this project, including, but not limited to, the following:
 - Review all design and construction documents prepared by the Architect/Engineer of Record (A/E), as well as all existing onsite conditions, to ensure constructability of the project. Review of existing conditions includes cost for all Ground Penetration Radar services;
 - Provide the District with value engineering analysis, cost saving recommendations and estimates throughout the various phases of design;
 - Prepare a master construction schedule to identify potential time saving measures and to facilitate the timely completion of the project;
 - Coordinate with District staff and project A/E to ensure that all necessary testing, permitting applications, and regulatory agency reviews are accomplished;
 - Identify all the various bid packages needed to successfully execute the project, and conduct pre-bid conferences with qualified sub-contractors, material suppliers, and equipment vendors.

3. All work shall be in compliance with the State Requirements for Educational Facilities, the Florida Building Code, National Fire Prevention Code, applicable life safety codes, barrier-free design guidelines, Florida Statutes, District Standards and District Policies. Passive design elements and low-energy usage features shall be incorporated in the work.

4. The cost of printing will be reimbursed by the Board on a direct cost basis, per conditions stipulated by the CMR Agreement.

5. Upon completion of the pre-construction services, the CMR firm shall negotiate a GMP for the construction project. If accepted, staff will submit the negotiated GMP for Board approval.
6. The CMR shall maintain no less than a \$500,000 Professional Liability Insurance policy with a maximum deductible of \$25,000, Worker's Compensation/Employers Liability Insurance, Comprehensive General Liability and Comprehensive Auto Liability Insurance.
7. The Agreement may be terminated by the Board, with cause or for convenience, prior to GMP, upon ten (10) days written notice to the CMR; whereas, the CMR may terminate the Agreement if the work is stopped for a period of 60 days through no act or fault of the CMR.
8. The CMR is required to submit a monthly report to the OEO documenting compliance with the Mandatory SBE/MBE Utilization Goals for sub-consultants and sub-contractors.
9. The CMR has agreed to the terms and conditions of the Agreement and will commence services upon Board commissioning.




