## LINK TO STRATEGIC BLUEPRINT: EFFECTIVE AND SUSTAINABLE BUSINESS PRACTICES

On April 17, 2013, the Board commissioned Alleguez Architecture, Inc., Architeknics, Inc., M. Hajjar & Associates, Inc., ProCon Engineering Inc., Robert E. Chisholm Architects, Inc., Saltz Michelson Architects, Inc., SBLM Architects, P.C., and Silva Architects, L.L.C., as Architectural/Engineering Projects Consultant (A/EPC) firms for miscellaneous projects with construction budgets up to \$2 million each, for a four-year term. At the Board Meeting of April 5, 2017, the Board authorized a six-month extension to the Agreements. The District's current A/EPC Agreements with the subject firms will expire on April 16, 2017, however, the A/EPC Agreements provide for extensions at the option of the Board.

To effectively support on-going, future and General Obligation Bond-funded projects, staff recommends that the A/EPC Agreements with all of the subject firms be extended for an additional six-month period, to expire on April 16, 2018, under the same terms, conditions and fees as the original Agreements, with any amendments thereto, at no additional cost to the Board. On October 4, 2017, staff received notification from Architeknics, Inc., declining the extension to their Agreement.

Staff requested updated information from the firms, and the firms submitted the requested documentation. The documents have been reviewed and accepted by staff.

All firms' professional and business licenses, and insurance certificates are current and in full force and effect.
