On Saturday, December 10, 2016, the Camping World Stadium in Orlando played host to the 2016 Florida High School Athletic Association (FHSAA) Class 6A football championship finals. The FHSAA Class 6A football championship game featured the Miami Carol City Senior High School Spartans and the Lakeland Lake Gibson Braves. After a scoreless first half in a hotly contested defensive match, Miami Carol City defeated Lake Gibson 14-6. making them the State champions. The Chiefs have the distinction of earning five state titles --- in 1977, with back-to-back championships in 1996 and 1997, and the last time the team participated in the State's final, in 2003.

The Miami Carol City Chiefs soundly defeated numerous opponents including the No. 2 \ Revised ranked Miami Northwestern Bulls with a dramatic 34-27 region semifinal victory; the state's top-ranked Daytona Beach Mainland Bucs by a score of 33-7 in the region finals and shut out the Punta Gorda Charlotte Fightin' Tarpons 39-0 in the state semifinals, to end the season with an 11-3 record.

Miami Carol City Senior High School boasts a rich history in the City of Miami Gardens that Revised has served several generations of Chiefs since the school was established in 1963. Its mission is to continue to build a professional learning community of life-long learners who will increase student achievement, personal integrity, civic responsibility, and workplace literacy as productive citizens of our community.

Principal JaMarv R. Dunn, Athletic Director Anthony Simons, Coach Aubrey Hill, the coaching staff, students, parents, and the Miami Carol City Senior High School football team are to be commended and celebrated for an exemplary 2016 season.

Further, Coach Aubrey Hill is to be congratulated for being nominated for the 2017 Don Shula NFL High School Coach of the Year Award, one of only three in the State of Florida.
