Mr. Cid also supported the Carbon Moxide Safety Law and a bill assisting Florida International University to recruit a new medical school faculty, both which successfully passed in the State Legislature.

In 2012, Mr. Cid was elected to the Miami Lakes Town Council, where he sponsored initiatives supporting a Performance-Based Budget structure, the 2015 Complete Streets Integration Strategic Plan, live webcasting of Town Council meetings, and many other items. Early into his term, Mr. Cid was elected Vice Mayor of the council for two years, making him the youngest Vice Mayor in history to serve in the position.

Mr. Cid is involved with various non-profit organizations, including the National Art Exhibition of the Mentally Ill and the Miami Dora Foundation. He is the Co-Founder and former President of the Hialeah-Miami Lakes Republican Club and serves as a youth baseball coach at Miami Lakes Optimist Park.
