In 1974-1975, he served as a teaching assistant at the University of Iowa while completing his Ph.D. In 1975, he returned to Miami-Dade as Principal of Lake Stevens Elementary School where he served until 1977. He was then promoted to Area Line Director for Elementary and Secondary Schools and served in that capacity in the South Central and North Area Offices. In 1979, Dr. Stinson became an Assistant Superintendent for the Bureau of Business Management and in 1981 he served as Area Superintendent for the North Central Area. In 1986, Dr. Stinson was promoted to the position of Associate Superintendent for the Bureau of School Operations and in January, 1991 he was Senior Associate Superintendent for School Operations. In June 1991, Dr. Stinson became Deputy Superintendent for School Operations serving this school district until his retirement in July 1996.

In November 1996, Dr. Stinson ran for office and was elected as the District 2 representative for the Miami-Dade School Board. During his first year, he was elected by his peers to serve as the Chair of the School Board and the first Chair to serve three consecutive terms (1996-1997, 1997-1998, and 1998-1999). He was re-elected to the School Board in November 1998, November 2002, and again in November 2006. Once again, Dr. Stinson was elected by his peers to serve as the Chair of the School Board for the terms 2008-2009 and 2009-2010. He retired on November 15, 2010 after serving fifty years with Miami-Dade County Public Schools.

Dr. Stinson is an active member of Mount Tabor Missionary Baptist Church where he serves as Chair of the Board of Trustees and Chair of Movers. He is a life member #10923 of Alpha Phi Alpha Fraternity, Inc. and Florida Congress of Parents and Teachers (PTA/PTSA). Additionally, he has been an active member of many organizations, which include, but are not limited to, the Executive Board of the Boys Scouts of America, Junior Achievement of Greater Miami, the Family Christian Association of America, the Board of Directors of Jobs for Miami, the Board of Directors for Inroads/Miami, Inc., the Association of Haitian Educators of Dade, and the Miami-Dade County Youth Fair and Exposition Association. He has also been a frequent recipient of many awards and recognitions from local, state, and national civic and professional organizations.

Dr. Stinson received his Bachelor of Science Degree from Alabama State University. He earned a Master of Arts Degree and a Doctor of Philosophy Degree from the University of Iowa.
