On April 17, 2013, the Board commissioned Alleguez Architecture, Inc., Architeknics, Inc., M. Hajjar & Associates, Inc., ProCon Engineering, Inc., Robert E. Chisholm Architects, Inc., Saltz Michelson Architects, Inc., SBLM Architects, P.C., and Silva Architects, L.L.C., as Architectural/Engineering Projects Consultant (A/EPC) for Miscellaneous projects with construction budgets up to \$2.0 million each, for a four-year term. The District has A/EPC Agreements in place with 32 firms. Agreements with the subject eight firms will expire on April 16, 2017, however, the A/EPC Agreements provide for extensions at the option of the Board.

To effectively support on-going, future and General Obligation Bond-funded projects, staff recommends that the A/EPC Agreements with these eight firms be extended for a six-month period, to expire on October 16, 2017, under the same terms, conditions and fees as the original Agreements, with any amendments thereto.
