Established in 2008 by world-renowned conductor James Judd, Miami Music Project's (MMP) mission is to use "music as an instrument for social transformation, empowering children to acquire values and achieve their full potential positively affecting their society through the study and performance of music." They use music to inspire children to reach excellence through their own efforts and aim to create opportunity and access for those most in need, ultimately improving their quality of life and future.

Since its inception, MMP has partnered with Miami-Dade County Public Schools to reach thousands of middle schools students through its comprehensive program curriculum, in-school residencies with interactive performances and educational support materials for classrooms. MMP has become one of the largest socially transformative music initiatives in the country, providing 500 Miami-Dade County Public School students with over 170,000 of instructional hours of programming annually, employing over 45 Teaching Artists, and emerging as a model for music education programs nationally and providing free, afterschool programming to all students regardless of race or economic status, with no barriers to entry. Program chapters are strategically located throughout the city in the neighborhoods of Little Haiti, Liberty City, Little Havana and Doral/West Dade. The students attend classes up to five times per week receiving on average up to 350 mentoring hours per student, per year.

Under the leadership of arts educator, administrator, and musician Anna Pietraszko, MMP began an evolution of its core focus into programming inspired by El Sistema, a visionary global movement that seeks to bring social change through music. As a result, the Miami Music Project Children's Orchestras were born. As of today, the Miami Music Project Children's Orchestras have achieved national prominence as one of the largest, most successful El Sistema-inspired USA-based programs. Students have performed at major venues in Miami including Adrienne Arsht Center and New World Center, and have traveled across US and the globe to Los Angeles, New York, Aspen, and Paris.

Through a partnership with FIU's Research Institute, evidence suggests that participation in MMP significantly impacts the lives of disadvantaged children in Miami-Dade County improving all factors of Positive Youth Development, specifically: grit, self-efficacy, goal-directed hope and empathy; students showed better psychological adjustment, reporting significant reductions in social anxiety, hyperactivity, and impulsive behavior; and the program improved executive functioning, specifically working memory.
