At the School Board Meeting of February 15, 2017, The Board rejected Request For Proposal No. RFP-16-008-AG - Workers' Compensation Claims Services: Surveillance and Investigation to permit rebidding and release with revised specifications which included a change to the pricing structure, moving from fixed, firm price to allowing the proposer the opportunity to competitively price their services. In addition, rebidding allowed the solicitation to be submitted to the District's Goal Setting Committee to increase potential vendor participation.

On April 5, 2017, staff released RFP 16-056-AG, Workers' Compensation Services: Surveillance and Investigation. The RFP is being structured for Miami-Dade County Public Schools (M-DCPS) to seek competitive proposals for an initial three-year period, with the ability to extend for two-additional one-year periods.

The RFP was advertised on the Procurement Management Services' website, the Demandstar website, Florida Bid, BidNet, and in the newspapers *Diario Las Americas* and *The South Florida Times*, emailed to 16 potential bidders and vetted through the Goal Setting Committee to increase SBE/MBE participation.

Surveillance and Investigation are important tools which reduce the cost of a workers' compensation claim. Services will be on an as-needed basis to assist in the handling of workers' compensation claims. Surveillance and Investigation services typically include the following:

- Field Surveillance
- Background Checks
- Activity checks
- Alive and Well Check
- Social Media Check
- Medical Canvass
- Hospital and pharmacy checks

Proposal responses were received on May, 11 2017. Thirteen (13) vendors responded to this advertised RFP; however, two (2) proposers were deemed unresponsive by the Office of Procurement Management. The Selection Committee met on May 25, 2017, in order to review proposals and make a final recommendation. Based on the committees' evaluation of the responses to the criteria listed in the RFP, six (6) vendors are being recommended for award. The following vendors are recommended for award:

- Claims Investigation Agency (MBE)
- G4S Compliance & Investigation, Inc.
- Jurney and Associates, Inc. (MBE)
- SIU Central Inc.
- S.K.I. Investigations (SBE Tier 1)
- Veracity Research Co.

(MBE) – Micro Business Enterprise (SBE- Tier 1) – Small Business Enterprise, Tier 1

Strategies were employed to increase SBE/MBE participation, and as such, 50% of the awardees are SBE or MBE certified vendors.

The Office of Procurement Management Services sought best and final pricing for each component of the RFP from the successful proposers. Final pricing for each category is detailed in the recommend:

RECOMMENDED: That the School Board of Miami-Dade County, Florida:

Authorize the Superintendent to enter into contracts with the following firms at the set pricing pursuant to the terms of Request For Proposals (RFP) 16-056-AG, Workers' Compensation Services: Surveillance and Investigation, for a three-year period, with the ability to renew for two additional one-year periods subject to mutual agreement between the parties, effective August 1, 2017. The cost of these services will be paid as allocated claims expenses.
