### Background:

At its meeting of October 14, 2015 (Item F-34), the Board commissioned Veitia Padron Incorporated (VPI), as the Construction Management at-Risk (CMR) firm for the renovations and repairs of Kenwood K-8 Center. As part of their pre-construction services, VPI has worked closely with the project Architect in developing Construction Documents by providing scheduling, as-built verification, constructability reviews and cost estimating services. This project is for the construction, renovation and repair of portions of the existing facility, and various site improvements. This contract provides a Guaranteed Maximum Price (GMP) for construction to the Board.

On May 12, 2017, fifty-three (53) sealed subcontractor bids were received and opened at the School Board Administration Building. The Project Architect and staff from the Office of School Facilities Construction witnessed the bid opening and tabulation process. Negotiations with VPI concluded successfully and the GMP agreed to for this project is \$3,122,313, which includes an Owner's contingency of \$106,197. This contract covers all required work and includes subcontracts, materials, contingency, general conditions, bonds, overhead, and profit.

The contract provides for compliance with Small and Micro Businesses Utilization Goals. The M-DCPS Office of Economic Opportunity staff reviewed the S/MBE and M/WBE certification status of all subcontractors and verified the existence of a Letter of Intent for each, outlining roles and responsibilities.

## Description and Scope

# **Existing Campus:**

Kenwood K-8 Center is located at 9300 S.W. 79 Avenue, Miami, Florida. The facility is bordered on the north by a single family residential neighborhood, on the west by S.W. 80 Avenue, on the east by S.W. 79 Avenue and on the south by a single family residential neighborhood. The existing school was built in 1927 with additions constructed afterwards, and is currently comprised of 15 permanent buildings situated on an approximately 17.33-acre parcel of land. The facility has a permanent capacity of 1,155 student stations.

## Project Scope:

The proposed scope of work for this project includes, but is not limited to: HVAC replacement and A/C in kitchen (Buildings 1, 2, 3 and 8); window replacement (Buildings 1, 2 and 3); group restroom renovations (Buildings 1 and 3) and single restrooms (Building 2 and 3) replacement of domestic water piping; safety-to-life system corrections; electrical upgrades and other selective interior renovations; structural upgrades (Building 1); shade structure to playground play area, covered walkway; selective exterior paint and other miscellaneous improvements throughout.
