Introduction

On April 24, 2017, a solicitation was published to competitively bid (Hard Bid) construction of the General Obligation Bond (GOB) funded Scott Lake Elementary, Palm Springs North Elementary, and Coral Park Elementary Schools. Bids have been received and this item provides a recommendation for award to the lowest responsive, responsible bidder.

Fifteen (15) pre-qualified contractors picked up plans and specifications. A mandatory pre-bid conference was conducted on March 9, 2017, for interested contractors and sub-contractors. Three (3) sealed bids were received and opened on May 24, 2017, at the School Board Administration Building Auditorium. The Project Architect and staff from the Office of School Facilities witnessed the bid opening.

After analysis of the bid tabulation (see Attachment A), it was determined that T & G was the lowest responsive, responsible bidder, with a sum total Base Bid price of \$9,775,000; inclusive of: Scott Lake Elementary School - \$3,375,000, Palm Springs North Elementary School - \$2,800,000 and Coral Park Elementary School - \$3,600,000.

No deductive alternates are being taken; however, the award amount is being reduced by \$195,500 inclusive of Scott Lake Elementary School - \$67,500; Palm Springs North Elementary School - \$56,000; and Coral Park Elementary School - \$72,000; as a result of sales tax savings generated by the District's Direct Materials Procurement Program. Consequently, District Staff and the Project Architect, Ms. Lourdes Rodriguez; Rodriguez Architects, recommend awarding the project to T & G in the amount of \$9,579,500.

The contract provides for compliance with Small/Micro Business and Local Workforce utilization goals. The Office of Economic Opportunity (OEO) reviewed the SBE/MBE and MWBE certification status of all subcontractors and verified the existence of a letter of intent for each, outlining roles and responsibilities.

Coral Park Elementary School:

T & G will provide Local Workforce Utilization of 20% for Construction, county-wide (as determined by the M-DCPS Goal Setting Committee).

The Office of Economic Opportunity shall monitor the above-stated goals for compliance.

Description and Scope**Existing Campus: Scott Lake Elementary School**

Scott Lake Elementary School is located at 1160 N.W. 175 Street, Miami Gardens, Florida. The facility is bordered on the north by N.W. 175 Street, on the east by N.W. 9 Place, on the west by N.W. 12 Avenue, and on the south by N.W 173 Terrace. The existing school was built in 1959 with additions constructed afterwards, and is currently comprised of 12 permanent buildings situated on an approximately 9-acre parcel of land. The facility will have a permanent capacity of 736 student stations once the project is completed.

Project Scope:

The proposed scope of work for this project includes: addition of a new 10 classroom prototype building with a total of 180 student stations, exterior paint, demolition of existing Buildings 2, 3 and 6, renovation of existing Buildings 1, 4 and 5; to include new windows and HVAC upgrades; new parent drop-off and covered walkway, demolition of 4 existing portables, and other miscellaneous improvements throughout.

Existing Campus: **Palm Springs North Elementary School:**

Palm Springs North Elementary School is located at 17615 N.W. 82 Avenue, Miami, Florida. The facility is bordered on the north by N.W. 178 Street, on the east by Norman and Jean Reach Park, on the west by N.W. 82 Avenue, and on the south by N.W. 176 Street. The existing school was built in 1969 with additions constructed afterwards, and is currently comprised of 8 permanent buildings situated on an approximately 12-acre parcel of land. The facility will have a permanent capacity of 1,085 student stations once the project is completed.

Project Scope:

The proposed scope of work for this project includes: addition of a 10 classroom, 180 student station building, which is the reuse of the prototype developed for Scott Lake Elementary, a new Physical Education shelter, two new basketball hardcourts, new covered walkway and other miscellaneous improvements throughout.

Existing Campus: **Coral Park Elementary School:**

Coral Park Elementary School is located at 1225 S.W. 97 Avenue, Miami, Florida. The facility is bordered on the north by S.W. 12 Street, on the east by the S.W. 94 Court, on the west by S.W. 97 Avenue, and on the south by Coral Estates Park. The existing school was built in 1960 with additions constructed afterwards, and is currently comprised of 14 permanent buildings situated on an approximately 9-acre parcel of land. The facility will have a permanent capacity of 1,020 student stations once the project is completed.

Project Scope:

The proposed scope of work for this project includes: addition of a new 12 classroom, 216 student station, prototype building, new flammable storage building, new Physical Education shelter, two new basketball hardcourts, new parent drop-off and covered walkway, new staff parking, demolition of the existing portables, demolition of existing Building 9 and 12, and other miscellaneous improvements throughout.
