

NOTICE OF INTENDED ACTION

THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, announced on May 24, 2017, its intention to amend Board Bylaw 0153, *Appointees*, at its regular meeting on July 12, 2017.

PURPOSE AND EFFECT: To amend Bylaw 0153, *Appointees*, to require the Board Clerk to maintain an historical record of Board Chair appointments to organizations, committees, and official councils within the Board, District and community and to require that the record be regularly updated and made accessible to the public.

SUMMARY: The Board Chair appoints School Board members and others to various organizations, committees, and official councils within the Board, the District, and the community. These appointments range from The Children's Trust to the Miami-Dade County League of Cities and many others. In order to improve the efficiency of the transition for each new Board chair and to establish the historical record of these appointments for community access, this policy amendment will require the Board Clerk to maintain a record of the Board Chair's appointments, regularly update the record, and ensure that it is accessible to the public.

LAWS IMPLEMENTED INTERPRETED OR MADE SPECIFIC: 1001.43(10), F.S.

IF REQUESTED, A HEARING WILL BE HELD DURING THE SCHOOL BOARD MEETING on July 12, 2017, which begins at 1:00 p.m., in the School Board Auditorium, 1450 N.E. Second Avenue, Miami, Florida 33132. Persons requesting such a hearing or who wish to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative as provided in Section 120.54(1), F.S., must do so in writing by June 20, 2017, to the Superintendent, Room 912, at the same address.

ANY PERSON WHO DECIDES TO APPEAL THE DECISION made by The School Board of Miami-Dade County, Florida, with respect to this action will need to ensure the preparation of a verbatim record of the proceedings, including the testimony and evidence upon which the appeal is to be based. Section 286.0105, F.S.

The Chair shall appoint members as necessary to organizations, committees, and/or councils as required by law, School Board policy, or as desired by the Board.

The Chair may appoint individual Board members to serve as liaison representatives from the Board to other official boards, agencies, and committees. Typical of such appointments are those to the Miami Dade County Department of Public Health and the Dade County League of Cities. The Board Clerk shall maintain a record of the Chair's appointments and shall regularly update that record and ensure that it is accessible to the public.

Board members may present reports of activities of these groups to the full Board at any regular meeting of the Board under the agenda heading, "Office of School Board Members."
