It is important to realize that learning disabilities can affect an individual's life beyond academics and can impact relationships in the workplace, and with family and friends. A learning disability cannot be cured or fixed; it is a lifelong challenge. However, with appropriate support and intervention, people with learning disabilities can achieve success in school, at work, in relationships, and in the community.

Diandre Incera, is a visually impaired 7<sup>th</sup> grader at Fienberg-Fisher K-8 Center whose famous life motto is "I'll give it a try." He has never let his disability impede his participation in any school or life activities. Diandre chooses to concentrate on his enhanced senses, rather than focus on his inability to see. He can recognize people by their footsteps, and has a gift for music. Diandre is known by teachers, staff and peers to be adaptable to any situation, and puts forth effort to participate in all activities. Diandre is always open to suggestions, and is known around campus for his incredible kindness. You might see him learning how to navigate the streets of South Beach with his orientation and mobility teacher, as independence is a life goal. Diandre participates in Special Olympics, playing basketball, soccer and bowling. Diandre took on the challenge of an overnight camping fieldtrip in the Everglades, even Slough Slogging. The next time anyone is faced with a challenge, a recommended strategy is thinking of Diandre and saying "I'll give it a try!"

Learning Disabilities Awareness Month is an annual campaign that takes place each October where people pay special attention to children and adults with learning disabilities.

It is important during Learning Disabilities (LD) Month to focus less on the disabilities aspect and focus more on the incredible abilities many of these individuals possess as well as emphasize the phenomenal achievements and important strides many of these individuals have made. Learning Disabilities (LD) affects millions of children and adults in school and in everyday life.

Approximately 58 million people in the United States have a disability. People with disabilities are people first, who happen to have a disability. Equal treatment is essential to the well-being and acceptance of our coworkers with a disability. Education is the key to helping people understand each other.
