## AMENDED CHARTER SCHOOL CONTRACT

Section 1002.33(7), F. S., states that the major issues involved in the operation of charter schools be considered in advance and written into a charter school contract between the charter school and the School Board following a public meeting. Further, Section 1002.33(7) allows that "a charter may be modified during its initial term or any renewal term upon the commendation of the sponsor or the charter school's governing board and the approval of both parties to the agreement." Pursuant to School Board Policy 9800, *Charter Schools*, one amended contract is being presented in this item for School Board approval retroactive to August 21, 2017. The recommendation is summarized in the following table:
