Procurement Management Services, at the request of the Office of School Operations, specifically the Division of Educational Opportunity and Access, released the above-referenced solicitation. The purpose of this Request for Proposal (RFP) is to solicit an agency that will provide academic services for a high performing, high impact school that will service District eligible students. This agency will target students who have not obtained a high school diploma and provide them the opportunity to 'drop back in' to an educational setting. Agency should provide research-proven instructional models, blended learning, and wrap-around services to successfully reengage students. This RFP was advertised on the Procurement Management Services website, the Demandstar website, BidNet and Florida Bid, as well as emailed to 181 potential bidders, which included ten (10) Small Business Enterprise (SBE) certified vendors and four (4) Micro Business Enterprise (MBE) vendors registered to these commodity codes.

The initial term of the bid shall be for three (3) years, commencing September 6, 2017 through September 5, 2020, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

Strategies were employed to increase SBE/MBE participation. The Goal Setting Committee recommended that this solicitation be open with 15% preference points for SBE/MBE certified proposers and 10% preference points for all local proposers.

The Selection Committee reviewed two (2) proposals: Acceleration Academies, LLC and Catapult Learning, LLC dba Specialized Education of Florida, Inc. After considerable discussion, request and submission of the Best and Final Offer and based on scoring criteria, the Selection Committee has recommended the award to both vendors.
