In an effort to increase the rate of inclusion of students with disabilities and enhance their academic achievement, the Superintendent's District Advisory Panel for Students with Disabilities, in collaboration with the Department of Exceptional Student Education, established the annual *Superintendent's District Advisory Panel Inclusion Achievement Award*.
