In these audited financial statements the external auditor, RSM US LLP, concluded that, in their opinion, "...the financial statements...present fairly, in all material respects, the respective financial position...of The School Board as of June 30, 2017, and the respective changes in financial position, and, where applicable, cash flows thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America." This language constitutes an unmodified opinion, which is the highest opinion that can be assigned to a financial statement audit. In conjunction with the yearly audit of the school system financial statements, RSM US LLP issued its Management Letter, which contains no findings. In addition, RSM issued a single audit report of the School Board's major federal programs. This report also contains an unmodified opinion and does not have any findings or questioned costs.
