### Introduction

On December 4, 2017, a solicitation was published to competitively bid (Hard Bid) construction of the General Obligation Bond (GOB) funded Ethel Koger Beckham Elementary School project. Bids have been received and this item provides a recommendation for award to the lowest responsive, responsible bidder.

Sixteen (16) pre-qualified contractors picked up plans and specifications. A mandatory pre-bid conference was conducted on December 19, 2017, for interested contractors and sub-contractors. Eight (8) sealed bids were received and these were opened on January 16, 2018, at the School Board Administration Building, Conference Room 321. The District staff from the Office of School Facilities and The Project Architect witnessed the bid opening.

After analysis of the bid tabulation (see Attachment A), it was determined Veitia Padron, Incorporated (VPI) was the lowest responsive, responsible bidder, with an adjusted Base Bid price of \$5,588,000.00. No deductive alternates are being taken; however the award amount is being reduced by \$111,760.00 as a result of sales tax savings generated by the District's Direct Materials Procurement Program. Consequently, District Staff and the Project Architect, Carty Architecture, recommend awarding the project to VPI in the amount of \$5,476,240.00.

M/WBE Utilization:

Aspirational M/WBE goals of 10% African American and 5% Women were established for this project (as determined by the M-DCPS Goal Setting Committee). Identified above are the M/WBE firms that Veitia Padron Incorporated will use on the project. Additional M/WBE subcontractors may be included in the project as the contractor finalizes the awarding of all their subcontracts.

Local Workforce Utilization:

VPI will provide county-wide Local Workforce Utilization of 20% for Construction (as determined by the M-DCPS Goal Setting Committee).

The Office of Economic Opportunity shall monitor the above-stated goals for compliance.

Description and Scope

Existing Campus:

Ethel Koger Beckham Elementary School is located at 4702 S.W. 143rd Court, Miami, Florida. The facility is bordered on the northwest by SW 47<sup>th</sup> St., on the northeast by SW 143<sup>rd</sup> Ct., on the west by Bird Lakes Park, and on the south by SW 48<sup>th</sup> Ln. The existing school was built in 1992 and is currently comprised of 8 permanent buildings situated on an approximately 11-acre parcel of land. The facility has a permanent capacity of 749 student stations and will have a total capacity of 1,127 student stations once the project is completed.

Project Scope:

The proposed scope of work for this project includes: construction of a new 378 student station, one-story classroom building comprised of 13 classrooms, one general science classroom, one science lab with associated storage spaces, one computer lab, one foreign language lab, an administration area, one multipurpose room with two student changing rooms, two student toilet rooms, two staff toilet rooms, one custodial service closet, one electrical room, 4 mechanical rooms, attached dining shelter, covered walkway connections, one new hard court, 36 additional parking spaces, landscaping, and drainage and irrigation systems.

- Substantial Completion February 21, 2019
- Final Completion/Acceptance March 21, 2019
