Background:

On February 4, 2019, a solicitation was published to competitively bid (Hard Bid) construction of the General Obligation Bond (GOB) New K-8 Center: Phase I - Grades K-5 School project. Bids have been received and this item provides a recommendation for award to the lowest responsive, responsible bidder.

Fourteen (14) pre-qualified contractors picked up plans and specifications. A mandatory pre-bid conference was conducted on February 22, 2019, for interested contractors and sub-contractors. Seven (7) sealed bids were received and these were opened on March 12, 2019, at the School Board Administration Building, Conference Room 522-A. The District staff from the Office of School Facilities and the Project Architect witnessed the bid opening.

After analysis of the bid tabulation (see Attachment A), it was determined that Thornton Construction Company, Inc. (Thornton) was the lowest responsive, responsible bidder, with a Base Bid price of \$13,121,111. No deductive alternates are being taken; however, the award amount is being reduced by \$262,422.22 as a result of sales tax savings generated by the District's Direct Materials Procurement Program. Consequently, District Staff and the Project Architect, Zyscovich Architects, recommend awarding the project to Thornton in the amount of \$12,858,688.78.

The contract provides for compliance with Small Business, Micro Business, Veteran Business and Minority Owned Business Utilization Goals. The Office of School Facilities Construction staff reviewed the SBE, MBE, VBE and M/WBE certification status of all subcontractors and verified the existence of a Letter of Intent for each, outlining roles and responsibilities.

Small/ Micro / Veteran Business Utilization:

A mandatory SBE/ MBE/ VBE participation goal of 15.99% for Construction was established for this project (as determined by the M-DCPS Goal Setting Committee). Identified below are the SBE/ MBE/ VBE firms that Thornton will use on the project.

Minority/Women Business Enterprise Utilization:

A mandatory M/WBE participation goal of 9.01%; encompassing African American, Native American and Asian American firms; was established for this project (as determined by the M-DCPS Goal Setting Committee).

Identified below are the SBE/ MBE/ VBE and M/WBE firms that Thornton will use on the project. Additional SBE/ MBE/ VBE and/or M/WBE subcontractors may be included in the project as the contractor finalizes awarding of all the subcontracts.

Thornton will provide Local Workforce Utilization of 20% for Construction within a 10-mile radius (as determined by the M-DCPS Goal Setting Committee).

The Office of Economic Opportunity shall monitor the above-stated goals for compliance.

Description and Scope

The vacant lot where the New K-8 Center: Phase I - Grades K-5 School will be situated upon completion is located at N.W. 102 Avenue and N.W. 78 Street, Miami, Florida. The site is bordered on the north by a conservation area, on the east by Northwest 102 Avenue, on the west by a townhouse development and on the south by Northwest 78 Street. The facility will be situated on an approximately 4-acre parcel of land and will have a total capacity of 750 permanent student stations once the project is completed.

The project is comprised of the initial Grades K-5 (Phase I) and will later expand to a full K-8 configuration (Phase II) under a separate project.

Project Scope:

The proposed scope of work for this project includes but is not limited to: construction of a new K-5 school facility comprised of classrooms, media center, full kitchen, cafeteria, administration offices, play courts, playfields, student drop-off areas and various other support spaces.
