The Miami-Dade County Water & Sewer Department is constructing improvements to a Regional Pump Lift Station ("Pump Station") located adjacent to the Miami Lakes Educational Center campus ("School"), located at 5780 N.W. 158 Street, Miami-Dade County, Florida 33014. In order to provide the necessary electrical service to the Pump Station, Florida Power & Light Company has requested that an easement be granted. The easement runs along the Northwest portion of the School site, is approximately 20' wide and consists of 304 square feet, or 0.006979 acre, more or less. The area is legally described in Exhibit "A", attached hereto.

The Office of School Facilities recommends granting of the proposed Easement. All documents have been reviewed by the School Board Attorney's Office and the Office of Risk and Benefits Management for legal sufficiency and risk management issues, respectively, and found to be in compliance.


**RECOMMENDED:**
