Pursuant to School Board Policy 7250, Commemoration of School Facilities and District Facilities, the School Facilities Naming/Renaming Committee met on Wednesday, May 22, 2019, to review all documents submitted for consideration for the renaming of Biscayne Elementary School, Fienberg/Fisher K-8 Center, Nautilus Middle School, and South Pointe Elementary School, located in the North Region.

The committee was comprised of the following voting members: Ms. Perla Tabares Hantman, Board Chair; Dr. Martin Karp, Board Member, District 3; a community member (see chart below) for each school to be renamed designated by the Board member in whose district the school to be renamed is located; Mr. Jose Bueno, Region Superintendent, North Region Office, and a community representative (see chart below) for each school to be renamed selected by the Region Superintendent in whose region the schools are located.
