Procurement Management Services, at the request of the Office of Facilities, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract for the supply and installation of carpet tile, resilient floor tile and resilient sheet flooring, as needed, for Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' and DemandStar websites. The solicitation was shared with the District offices for additional community outreach, including but not limited to social media, local newspapers, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a two (2) year period, commencing June 19, 2019 through June 18, 2021 and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open with 5% SBE/MBE preference points and/or 5% preference points for local vendors.

Three (3) vendors responded to this solicitation. Based on the criteria listed in the ITB, the contract shall be awarded to three (3) vendors, who are MBE/WMBE certified.

Currently there is no bid in place. As such, a dollar amount is not available of the spent for FY 2017-2018.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status.
