Procurement Management Services, at the request of Facilities Operations, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a pool of pre-approved vendors with catalog discounts for the supply and repairs of electric clocks, intercom systems, and time stamp machines. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' and Demandstar websites. The solicitation was shared with District offices for additional community outreach, including but not limited to social media, local newspapers, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a three (3) year period, commencing July 24, 2019 through July 23, 2022 and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open competitive with 5% SBE/MBE or 5% local preference.

Four (4) vendors responded to this solicitation. Based on the criteria listed in the ITB, the contract shall be awarded to four (4) vendors, one (1) MBE/MWBE certified.

In FY 2017-2018, the District spent \$1,866,275 on electric clocks, intercom systems, time stamp machines, parts and supplies.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firm and all subcontractors.
