Procurement Management Services, at the request of School Operations, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a preapproved vendor list for design, development, support, and maintenance of ADA compliant websites at Miami-Dade County Public Schools. This term bid states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services and DemandStar websites. The solicitation was shared with District offices for additional community outreach, and its various media platforms, including but not limited to social media, local newspapers, local radio stations, and prior bid forecasting lists.

The initial term of the bid shall be for a period of three (3) years, commencing July 24, 2019, through July 23, 2022, and may, by mutual agreement between the School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE/VBE (Small/Micro Business Enterprise/Veteran Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open with a 5% SBE/MBE/VBE or 5% local participation rate.

Twenty-one (21) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to twenty (20) vendors of which four (4) of the awarded vendors are SBE/MBE.

In Fiscal Year 2017-2018, the District spent \$318,940 on website development contracts.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firms and all subcontractors.
