The District recently received an inquiry from an interested purchaser of two Board-owned contiguous parcels of vacant land, each approximately 21,450 square feet in size, located directly across the street from the Florida City Elementary School ("School") campus, at 364 N.W. 6 Avenue, Florida City, FL 33034. The South Region Superintendent was contacted by staff and confirmed that the parcels are not anticipated to be required by the School for expansion or other educational purposes. In conformance with Board Policy 7315 – Disposal of Surplus Land and Other Real Property, the Board is to establish the fair market value of any property it seeks to dispose of in a potential public sale.
