Procurement Management Services, at the request of District Alarms and Inspections, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract to furnish necessary labor, transportation, material and equipment to test, service, inspect, repair and maintain fire suppression systems, for Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services' and DemandStar websites. The solicitation was shared with the District offices for additional community outreach, including but not limited to social media, local newspapers, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a three (3) year period, commencing September 4, 2019 through September 3, 2022, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods. At the time of contract extension, additional vendors may be added and/or removed, at the discretion of the District.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open.

One (1) vendor responded to this solicitation. Based on the criteria listed in the ITB, the contract shall be partially awarded to one (1) vendor, who is SBE/MWBE certified. No bid pricing was received for Group 1. Although pricing was submitted for Group 2, the vendor is not qualified, as required by this ITB, to provide such service. As such, the recommendation requests that Group 1 and Group 2 items be rejected, to allow for rebidding.

In FY 2018-2019, the District spent \$48,641 on fire suppression systems.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firm and all subcontractors.
