In these audited financial statements the external auditor, RSM US LLP, concluded that, in their opinion, "...the financial statements...present fairly, in all material respects, the respective financial position...of The School Board of Miami-Dade County, Florida, as of June 30, 2019, and the respective changes in financial position, and, where applicable, cash flows thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America." This language constitutes an unmodified opinion, which is the highest opinion that can be assigned to a financial statement audit.

In conjunction with the yearly audit of the School Board's basic financial statements, RSM US LLP issued its Management Letter with no findings to report.

The School Board Audit and Budget Advisory Committee reviewed these reports at its December 3, 2019, meeting and recommended transmission to the School Board.
